FRIENDLY REMINDER – CANCELLATION POLICY

Advance Cancellations

Cancellations made at least 24 hours in advance of the scheduled session will not be charged.

Late Cancellations


Late cancellations include those made within 24 hours of the scheduled session.

Examples:

- For a session at 1:00 p.m. on Tuesday, cancellation must be received before 1:00 p.m. on Monday.
- For a session at 10:00 a.m. on Monday, cancellation must be received before 10:00 a.m. on Saturday, as Sunday is a non-business day

Cancellations must be communicated during clinic business hours. Any cancellation received outside business hours or within the 24-hour window will be classified as a late cancellation.

In cases of late cancellation, the full session fee will be charged, regardless of the reason. When a session is booked, that time cannot be allocated to another client, resulting in a loss of income for the clinician. This policy helps ensure fairness to both families and clinicians.



Important Update: Occupational Therapy Rate Adjustment

Effective March 1, 2026, the hourly rate for Occupational Therapy services will be adjusted to \$180.

This update reflects our ongoing commitment to delivering consistent, high-quality care for the children and families we serve. The adjustment supports therapist retention, continuity of care, and strengthened clinical leadership with the addition of our new OT Clinic Lead, ensuring enhanced oversight and service quality.

We recognize the importance of funding considerations and remain committed to supporting families wherever possible.
